CIVIL AVIATION ACT 1976 AIR NAVIGATION REGULATIONS 1981

APPROVAL

I, Joseph E Konrote, a delegate of the Civil Aviation Authority of Fiji (CAAF) under the Fiji Air Navigation Regulation 145B (2) – after having reviewed the course on offer including required amendments, the Operations Manual and section 2 of the Curriculum Manual hereby approve the CONTRACT AIRCREW TRAINING LTD Web based Flight Crew Dangerous Goods Awareness – Fiji, Training programme, subject to the following conditions:

Purpose

The purpose is to approve the Contract Aircrew Training Ltd as an Aviation Training Institute that provides Web based Dangerous Goods Awareness training for Fiji Flight Crew.

Application

This approval applies to the Web based Flight Crew Dangerous Goods Awareness – Fiji, Training programme offered/managed by Contract Aircrew Training Ltd on their website www.conair.co.nz for use by holders of CAAF Flight Crew license.

The following approval Conditions and Validity conditions are laid out under the provisions of the Fiji Air Navigation Regulation 145B(3)

Conditions

This approval is subject to the following conditions:

1. Contract Aircrew Training Ltd shall make such amendments or additions to the training programme as the CAAF may require for the purpose of ensuring the safety of the aircraft or of persons or property carried therein or the safety, efficiency or regularity of air navigation.
2. Contract Aircrew Training Ltd may only make relevant changes to the training programme as required under the Fiji Air Navigation Regulations 1981, the International Civil Aviation Organization (ICAO) – Technical Instructions (TI) for the Safe Transport of Dangerous Goods by Air, and the International Air Transport Association (IATA) – Dangerous Goods Regulations (DGR), in force from time to time, without CAAF approval.
3. Contract Aircrew Training Ltd must provide to the CAAF such information as the Authority may from time to time require for the purpose of ensuring the safety of the aircraft or of persons or property carried therein or the safety, efficiency or regularity of air navigation.
4. Changes made under conditions 1 & 2 above shall be notified to CAAF.
5. That Contract Aircrew Training Ltd maintains courses at a satisfactory standard.

Validity

This approval is in effect until the earliest of the following:

- a. the date on which any condition set out in this approval is breached; or
- b. the date on which this approval is cancelled in writing by the CAAF where it is of the opinion that it is no longer in the public interest or is likely to affect aviation safety.
